Left Vienna in Nov 1939 in a large group that got stuck in Yugoslavia at KLADOVO and later at SABAC. After the Germans and Austrians invaded they were put in a camp called SAVA. Her last letter is dated "Sabac 6 Dec 1941" with a stamped number (Red Cross?) 207201. In Jan 1942 they were moved to SAJMISTE camp. Most of the women were gassed in van journeys to Jajinci near Belgrade between March and May 1942, buried there but exhumed and burnt in Dec 1943/Jan 1944 (see trials of Schäfer, Enge, Andorfer, Yad Vashem Archives TR-10/266, TR-10/656, TR-10/900). A few were shot at Zasavica around 17 May 1942 and it was reported to her children in 1945 that her body was recognised among those when exhumed at Zasavica in June 1945. Much of this is detailed in Dead-end Journey: The Tragic Story of the Kladovo-Šabac Group, by Dalia Ofer and Hannah Weiner, 1996.
